বাঙালিদের মধ্যে জনপ্রিয় ছট উৎসব বর্ধমান আদালতে জামিন পেলেন দিলীপ ঘোষ

দুরন্ত বার্তা, বর্ধমান, ১৯ নভেম্বরঃ বাঙালীর বারো মাসে তেরো পার্বণ হলেও একটানা পুজো-উৎসবের মরশুম বলতে সাধারণত প্রাকঃ শারদীয়ার বিশ্বকর্মা পূজো থেকে শুরু করে মহালয়া, দুর্গাপুজো, লক্ষ্মী পুজো, কালীপুজো হয়ে ভাতৃ দ্বিতীয়াতে শেষ হত। তবে আঞ্চলিক ভিত্তিতে এই পুজো-উৎসবের সময়কাল কার্তিক ও জগধাত্রী পুজো অবধি গড়াতো। তবে বিগত কয়েক দশক ধরে লক্ষ্য করা যাচ্ছে দীপাবলীর ঠিক ছদিন পর অর্থাৎ কার্তিক মাসে শুক্লপক্ষের ষষ্ঠী তিথিতে ছট বা সূর্য পুজো বাঙালিদের মধ্যে ক্রমশ জনপ্রিয় হয়ে উঠছে। প্রধানত পূর্ব ভারতের বিহার ও ঝাড়খন্ড, উত্তর প্রদেশের পূর্বাঞ্চলে ও পড়শি দেশ নেপালের তরাই অঞ্চলে ছট পুজো আড়ম্বরের সাথে পালিত হলেও ভারতের অন্যান্য রাজ্যগুলি সহ আমাদের রাজ্যে বসবাসকারী অবাঙালিরাও ছট পুজো আগের তুলনায় অনেক বেশী ধুমধামের সাথে পালন করছেন। ছট পুজোর জনপ্রিয়তা ও তার উপাচার পদ্ধতি আকর্ষন করেছে বাঙালিদেরও। অবাঙ্গালি বন্ধু কিম্বা প্রতিবেশীদের সাথে অনেক বাঙালিও পুকুর ঘাটে কোমর জলে ডুবে আরাধনা করছে ছটি মাইয়ার। বৈদিক যুগের আগে থেকেই চলে আসছে সূর্য দেবতার পূজো এবং এই পূজো হয় ষষ্ঠীর দিনে। এই ষষ্ঠ বা ছয় কথাটা নেপাল ও উত্তর ভারতে অনেকে ছট বা ছঠ বলে থাকেন। সেখান থেকেই ছট শব্দটির উৎপত্তি। ত্রেতা যুগে শ্রীরামচন্দ্র ও সীতাদেবী এই ষষ্ঠীর দিন এই সূর্যদেবের

আরাধনা করেছিলেন, আবার দ্বাপরে অঙ্গদেশের রাজা সূর্যপুত্র কর্ণও সূর্যদেবের পুজো করে করতেন। মহাভারতে দ্রৌপদী ও পঞ্চপান্ডব পালন করেছিলেন এই উৎসব। পৌরানিক মতে সূর্য দেবতা এবং তার দুই পত্নী উষা ও প্রত্যুষার আরাধনা করা হয় ছট পূজোয়। আবার অন্য এক পৌরানিক মতে সর্যদেবের ছোট পত্নী উষাকেই 'ছটি মাইয়া' হিসাবে অভিহিত করে তার আরাধনা করা হয়। মূলত চার দিন ব্রতপালন করে ছট পুজো করা হয়। ব্রতের প্রথম দিন ঘর-বাড়ি পরিস্কার করে স্নান সেরে শুদ্ধাচারে নিরামিষ ভোজন করতে হয় যাকে নাহায়-খায় বলা হয়। দ্বিতীয় দিন দিনভর নির্জলা উপবাসের পর সন্ধ্যার পুজো সেরে ক্ষীরের ভোগ গ্রহন করা হয় যাকে 'খরনা' বলা হয়। তৃতীয় দিন অস্তগামী সূর্যকে পুকুর নদী বা অন্যান্য জলাশয়ে গিয়ে দুধ সহ বিভিন্ন অর্ঘ্য প্রদান করতে হয়। পরের দিন ভোরবেলা ফের একবার জলাশয়ে গিয়ে উদীয়মান সুর্যদেবকে ডালিতে করে ঠেকুয়া, ভাতের নাড়ু, খাস্তা টিকরি, নারকেল, আখ, লেবু, কলা, গুড়, ক্ষীর সহ বিভিন্ন মিষ্টান্ন দ্রব্য সমেত অর্ঘ্য প্রদান করে সেই প্রসাদ বিতরণ ও গ্রহন করে উপবাস ভঙ্গ করতে হয়। বর্ধমান শহরের অবাঙালী অধ্যুষিত এলাকায় বেশ জাঁকজমকের সাথে পালিত হয়ে আসছে ছটপুজো। তবে এবারে করোনা পরিস্থিতিতে বেশ কিছু সরকারী নিষেধাজ্ঞা থাকায় উদ্দীপনা থাকলেও আয়োজন কিছুটা কমানো হয়েছে বলে জানা গেছে। শহরের মেহেদি বাগান,

লক্ষীপুর মাঠ, বোরহাট, নতুনগঞ্জ ইদিলপুর, লোকো কলোনি ইত্যাদি বিভিন্ন প্রান্তে প্রায় ৩০-৩৫টি ছট পুজো কমিটি গড়ে উঠেছে যারা সৃষ্ঠ ও সূচারু রূপে এই উৎসব পালনে সহযোগিতা করছে। কোনরকম অপ্রীতিকর ঘটনা এড়াতে পুলিশ ও প্রশাসনের পক্ষ থেকেও ছটপুজোয় যথেষ্ঠ সহযোগিতার হাত বাড়িয়ে দেওয়া হয়েছে। পুলিশ ও প্রশাসনের আধিকারিকরা সদরঘাট সহ জেলার বিভিন্ন ঘাটগুলি পরিদর্শন করছেন। শহরের ভিতরকার বেশ কিছু পুকুর ছাড়াও দামোদর নদ ও বাঁকা নদীতে সূর্যদেবের আরাধনা করা হয়। তবে অভিযোগ উঠেছে, শহরের অধিকাংশ পুকুর বা জলাশয়গুলি সংস্কারের অভাবে নোংরা ও আবর্জনায় ভর্তি থাকায় অনেকেই বাড়ির কাছের পুকুরে ছট পুজো করতে পারছেন না। তাই তাদের গাড়ি ভাড়া করে সদর্ঘাটের দামোদর, কিম্বা বাঁকা নদীতে যেতে বাধ্য হচ্ছেন যা ব্যয়বহুল ও সময় সাপেক্ষ। অবাঙালিদের সাথে সাথে বাঙালিরাও এখন ছট পুজোয় সামিল হচ্ছেন। বর্ধমানের মেহেদী বাগানের বাসিন্দা মালতি দাস ও লোকো কলোনীর বাসিন্দা সঙ্গীতা দলুই জানিয়েছেন, অবাঙালি অধ্যুষিত এলাকায় তারা বাস করেন। দুর্গাপজা, কালীপুজোয় যেমন সেখানকার অবাঙ্গালী বাসিন্দারা যোগদান করেন উপবাস রাখেন, পুত্পাঞ্জলি দেন, তেমনি ছট পুজোতেও তারা ব্রত রাখেন ও এক কোমড় জলে দাঁড়িয়ে ছটি মাইয়ার কাছে সংসারের কল্যাণ কামনা করেন।

অভিযোগ, ২০১৯ সালের ৪ নভেম্বর রায়নায় এক জনসভা থেকে পলিশকে উদ্দেশ্য করে আপত্তিকর মন্তব্য করেন দিলীপ ঘোষ। সেই দিনই দিলীপ ঘোষের বিরুদ্ধে রায়না থানায় অভিযোগ করেন রায়নার এক বাসিন্দা। অভিযোগের পরিপেক্ষিতে রায়না থানায় ভারতীয় দণ্ডবিধির ১৫৩, ৫০৪ ও ৫০৫(১) ধারায় মামলা শুরু করে পুলিশ। ২০২০ সালের ফ্রেব্রুয়ারি মাসে দিলীপ ঘোষকে পলাতক দেখিয়ে চার্জশিট

দুরন্ত বার্তা, কোচবিহার, ১৯ নভেম্বর ঃ প্রায় ছয় মাসেরও বেশি সময় ধরে তাদের সাম্মানিক বকেয়া রয়েছে। এই অভিযোগ এনে দ্রুত বকেয়া সাম্মানিক প্রদানের দাবিতে বৃহম্পতিবার হাসপাতালের গেটে তালা ঝুলিয়ে দিয়ে বিক্ষোভ দেখালেন কোচবিহার জেলার মেখলিগঞ্জ ব্লকের বিভিন্ন লিংক ওয়ার্কার, ভ্যাকসিন ক্যারিয়ার, টিডিগণ। এদিন তারা চ্যাংরাবান্ধা ব্লক প্রাথমিক স্বাস্থ্যকেন্দ্রের অফিসের বাইরে তালা ঝুলিয়ে অফিসের সামনে বসে পরে আন্দোলন শুরু করেন। সকাল থেকে তাদের এই আন্দোলনের জেরে হাসপাতাল চত্বরে কিছুটা উত্তেজনাও ছড়ায়। হাসপাতালের অফিস থেকে জিনিসপত্র বের করা সম্ভব না হওয়ায় ব্লকের বিভিন্ন সেন্টারগুলিতে পরিষেবায় বিঘ্ন ঘটে। আন্দোলনকারীদের তরফে অমর রায়, রাজমনি রায়, জবেদা খাতুন প্রমুখ অভিযোগ করেন, তাদের দীর্ঘদিন ধরে সান্মানিক বকেয়া রয়েছে। এতে অনেকেই চরম বিপাকে পড়েছেন। সমস্যার কথা কর্তৃপক্ষকে একাধিকবার জানানোর পরেও কোনও লাভ হয়নি।যার কারণেই এদিন তাঁরা বাধ্য হয়ে আন্দোলন শুরু করেন। দ্রুত দাবি পুরণ না হলে পরবর্তীতে তাঁরা আরও বড় মাপের আন্দোলন গড়ে তুলবেন বলে জানিয়েছেন। যদিও হাসপাতাল কর্তৃপক্ষের তরফে জানানো হয়েছে তাঁরা কোনও কিছু না জানিয়েই এদিন অফিসের গেটে তালা ঝুলিয়ে দেন। এতে পরিসেবায় বিঘ্ন ঘটে। বর্তমানে হাসপাতালে চিকিৎসকেরও যথেষ্ট অভাব রয়েছে। বর্তমানে হাসপাতালের একমাত্র স্থায়ী চিকিৎসক ডাঃ উত্তম রায় টানা ৭২ ঘন্টা ধরে ডিউটি করে চলেছেন। হাসপাতালের চিকিৎসক তথা দায়িত্বপ্রাপ্ত বিএমও এইচ ডাঃ উত্তম রায় জানান, এদিন কোনওরকম আগাম না জানিয়ে তালা ঝুলিয়ে আন্দোলন শুরু করেন ওইসব কর্মীরা। তবুও তিনি বিষয়টি নিয়ে তাদের সাথে আলোচনায় বসতে চেয়েছিলেন কিন্তু তারা আগ্রহ দেখাননি। বিষয়টি তিনি উধৰ্বতন কৰ্তৃপক্ষকেও জানিয়েছেন।

সীমান্তে নিহত এক গরু পাচারকারী

দুরন্ত বার্তা, কোচবিহার, ১৯ নভেম্বর ঃ সীমান্ত রক্ষী বাহিনীর গুলিতে নিহত এক গরু পাচারকারী। এই ঘটনায় চাঞ্চল্য ছড়িয়েছে কোচবিহার জেলার হলদিবাড়ি ব্লকের দেওয়ানগঞ্জ গ্রাম পঞ্চায়েতের অধীন মিস্ত্রি পাড়া এলাকায়। অজ্ঞাত পরিচয় ওই ব্যক্তির কাছ থেকে ৪টি গরু উদ্ধার হয়। এদিন শীতের রাতে ঘন কুয়াশার সুযোগ নিয়ে ১৪৩ নম্বর ব্যাটালিয়নের ভোজলি পাড়া বিওপির অন্তর্গত ওই এলাকার আন্তর্জাতিক সীমান্তের কাঁটা তারের বেড়া কেটে বাংলাদেশে গরু পাচার চলছিল। বিষয়টি কর্তব্যরত সীমান্ত রক্ষী বাহিনীর নজরে এলে তাঁদের নিরস্ত হওয়ার নির্দেশ দেয়। তাতে ক্ষিপ্ত হয়ে এক পাচারকারী ধারালো অস্ত্র হাতে সীমান্ত রক্ষী বাহিনীর সদস্যদের দিকে তেড়ে আসে। তখন প্রাণে বাঁচতে গুলি চালায় সীমান্ত রক্ষী বাহিনীর এক সদস্য। অত্যাধুনিক রাইফেলের গুলি পাচারকারীর বুকে লাগে। গুলিটি এফোর ওফোর হয়ে যায়। তৎক্ষণাৎ কাঁটাতারের সামনে লুটিয়ে পড়ে সে। ঘটনাস্থলে তাঁর মৃত্যু হয়। অন্যরা পালিয়ে যেতে সক্ষম হয়। বৃহস্পতিবার সকালে গিয়ে হলদিবাড়ি থানার পুলিশ ওই মৃতদেহকে উদ্ধার করে হলদিবাড়ি গ্রামীণ হাসপাতালে নিয়ে আসে। ঘটনার তদন্ত করতে হলদিবাড়িতে আসেন মেখলিগঞ্জের মেজিস্ট্রেট। দেহটি ময়নাতদন্তের জন্য উত্তরবঙ্গ মেডিকেল কলেজ ও হাসপাতালে পাঠানো হয়েছে। হলদিবাড়ি থানার আইসি দেবাশিস বসু বলেন, মৃত ব্যক্তির পরিচয় জানা যায়নি। পুলিশ ঘটনার তদন্ত শুরু করেছে।

টাকা ফেরতের দাবী পোস্ট অফিসে

দুরন্ত বার্তা, রায়গঞ্জ, ১৯ নভেম্বর ঃ গ্রাহকদের প্রায় আড়াই কোটি টাকা প্রতারণা করে চম্পটের অভিযোগ পোস্টমাস্টারের বিরুদ্ধে। ঘটনাটি ঘটেছে, ইটাহার ব্লকের হাটগাছি সাব পোস্ট অফিসে। জানা গিয়েছে, প্রতারণা চক্রের মল অভিযক্ত ওই সাব পোস্ট অফিসের পোস্টমাস্টার রোজিনা পারভিন। কয়েকটি গ্রামের দরিদ্র মানুষগুলির কন্তার্জিত টাকা নিয়ে পালালেও আজ পর্যন্ত পোস্টমাস্টারকে গ্রেফতার করতে পারেনি পুলিশ। ফলে এলাকার বাসিন্দাদের মধ্যে ক্ষোভের সৃষ্টি হয়েছে। প্রতারিতদের অভিযোগ, একাধিকার ডাকঘর কর্তৃপক্ষকে জানালেও তাঁরা আজ পর্যন্ত টাকা ফেরতের কোনও আশ্বাস পাননি। এরপর আর কোনও পথ না পেয়ে বৃহস্পতিবার হাটগাছি পোস্ট অফিসের প্রতারিত বেশ কিছু গ্রাহক টাকা ফেরতের দাবিতে রায়গঞ্জ মুখ্য ডাকঘরের সামনে এসে বিক্ষোভ দেখান। অবিলম্বে পোস্টমাস্টারকে গ্রেফতার ও টাকা ফেরতের দাবিতে সোচ্চার হন। এরপর প্রতারিতরা পোস্ট অফিসের অ্যাসিস্ট্যান্ট সুপারিন্টেনডেন্ট রবি লামার দপ্তরে যান। কিন্তু তিনি ছুটিতে থাকায় তাঁর সঙ্গে দেখা করতে পারেননি। আগামী সোমবার অ্যাসিস্ট্যান্ট সুপারিন্টেনডেন্ট রবি লামা দপ্তরে এসে তাদের সঙ্গে কথা বলবেন বলে আশ্বাস দিলে তাঁরা বিক্ষোভ তুলে নেন।

অজ্ঞাতপরিচয় দেহ উদ্ধারে চাঞ্চল্য

দুরন্ত বার্তা, মুর্শিদাবাদ, ১৯ নভেম্বর ঃ অজ্ঞাত পরিচয় এক যুবকের দেহ উদ্ধারের ঘটনায় চাঞ্চল্য ছড়াল এলাকায়। বৃহস্পতিবার দুপুরে ফরাকার বাঁধ প্রকল্পের তালতলা ঘাট শিব মন্দিরের পাশে একটি মাঠে যুবকের দেহ উদ্ধার হয়। স্থানীয় সূত্রে খবর, এদিন শিব মন্দিরের পাশে একটি মাঠে পাঁচিলের পাশে ওই যুবকের দেহ দেখতে পান স্থানীয় এক যুবক। মৃতদেহ পড়ে থাকতে দেখে সে চিৎকার শুরু করে। তাঁর চিৎকার শুনে এলাকাবাসী ঘটনাস্থলে পৌঁছায়। খবর দেওয়া হয় ফরাক্কা থানাতে। পুলিশ ঘটনাস্থলে পৌঁছে মৃতদেহ উদ্ধার করে। প্রাথমিকভাবে পুলিশের অনুমান, ওই যুবককে ২-৩ দিন আগে খুন করে ওই এলাকায় ফেলে গিয়েছে কেউ বা কারা। এই বিষয়ে বেওয়া-১ গ্রাম পঞ্চায়েতের প্রধান কুণাল ঘোষ বলেন, 'শিব মন্দিরের পাশে পাঁচিলটি তৈরি হওয়ার পর থেকে দুষ্কৃতী কার্যকলাপ বেড়ে চলেছে। আগেও আমরা পুলিশকে বিষয়টি জানিয়েছিলাম।' তিনি বলেন, 'প্রাথমিকভাবে মনে হচ্ছে, ওই যুবককে ২-৩ দিন আগে খুন করা হয়েছে, কারণ তাঁর দেহ ফুলতে শুরু করেছে এবং দেহ থেকে পচনের গন্ধ ছড়াচ্ছে। কিভাবে এবং কেন এই ঘটনা তা তদন্ত করে দেখছে পুলিশ।

খুলল চা বাগান

দুরন্ত বার্তা, জলপাইগুড়ি, ১৯ নভেম্বর ঃ খুলে গেল ডুয়ার্সের বিন্নাগুড়ি চা বাগান। চলতি মাসের ১৪ তারিখ ডুয়ার্সের বিন্নাগুড়ি চা বাগান কর্তৃপক্ষ বাগান ছেড়ে চলে যায়। যার জেরে বাগানে কর্মরত প্রায় ১৫০০ জন শ্রমিক কর্মহীন হয়ে পরেন। বুধবার অ্যাডিশনাল লেবার কমিশনারের দপ্তরে বৈঠকের পর আজ বিন্নাগুড়ি চা বাগানে খুল যাওয়ায় খুশির হাওয়া চা শ্রমিকদের মধ্যে। ত্রিপাক্ষিক বৈঠকে সিদ্ধান্ত হয়, মালিক ও শ্রমিকপক্ষ একে অপরের সঙ্গে তাল মিল বজায় রেখেই কাজ করবে। দাবি-দাওয়া নিয়ে আলোচনায় বসবে। মিটিয়ে নেবে। যে ক'দিন বাগান বন্ধ ছিল সেই ক'দিনের টাকা শ্রমিকরা পাবেন না। আগামী ডিসেম্বর মাসে ফের শ্রমিকপক্ষ ও মালিকপক্ষ আলোচনায় বসে বিভিন্ন দাবি-দাওয়া নিয়ে আলোচনা করবেন। মালিকপক্ষের অভিযোগ, না জানিয়ে ১০ ও ১১ তারিখে কাজ বন্ধ করে দেওয়া হয়। দ'টি শ্রমিক সংগঠনের ছাতার তলায় বিভিন্ন দাবি-দাওয়া নিয়ে আন্দোলন শুরু হয়। লিখিত বা মৌখিকভাবে কিছু না জানিয়েই কাজ বন্ধ করে আন্দোলনে সামিল হন শ্রমিকরা। ওই সংগঠন দু'টি শ্রমিকদের কর্মসংস্কৃতি নষ্ট করে দিছে। কয়েকজন শ্রমিক নেতা নিজেদের স্বার্থ চরিতার্থ করার জন্য এই আন্দোলন করছিলেন। তাতে ক্ষতি হচ্ছিল শ্রমিকদের। যার জেরেই চা বাগান ছেড়ে চলে যায় তারা। তবে আপাতত ত্রিপাক্ষিক বৈঠকে উভয়পক্ষ তাল মিল বজায় রেখে কাজ করবে বলে সিদ্ধান্ত নেওয়া হয়। আজ থেকে ফের চা বাগান ফিরল পুরোনো ছন্দে। ফের চা বাগান খুলে যাওয়ায় খুশির আবহাওয়া শ্রমিক মহল্লাগুলিতে।





લંડન, બ્રિટનના વડાપ્રધાન બોરિસ જોન્સન આગામી સપ્તાહે દેશમાં વર્ષ ૨૦૩૦થી પેટ્રોલ ડીઝલના વેચાણ પર પ્રતિબંધ જાહેર કરવા જઈ રહ્યા છે. અગાઉ વર્ષ ૨૦૩૫થી આવો પ્રતિબંધ અમલી બનાવવાની યોજના હતી. પરંતુ હવે પાંચ વર્ષ પહેલાં જ પ્રતિબંધ અમલી બનાવવા નકકી થયું છે. આમ તો ગ્રીન હાઉસ ગેસ ઉત્સર્જનને ઘટાડવા માટે દેશમાં વર્ષ ૨૦૪૦થી પેટ્રોલ અને ડીઝલ સંચાલિત કારના વેચાણ પર મનાઈ


